I, \_\_\_\_\_ (Parent/Guardian if student is under the age of 18) hereby agree to the terms and conditions below.

I accept that any all fees are non- refundable.

I accept that I am accountable for all fees associated with my enrolled classes for a period of term, regardless on attendance, refunds and credits will not be given for missed classes, or if chosen to discontinue attendance part way through a term, balances will remain due.

I accept that any all fees that are late will incur a 10% late fee on balances owed.

I accept that any unpaid balance of fees will remain due. Debt collection activities may include legal action and incurring charges and registering any default with a credit rating provider.

I agree that fees will be paid upfront via cash or EFT prior to commencing classes by the due dates listed on invoices or using the portal for creditcard (incurring 3% charge).

Should I choose to pay via EZIDEBIT, I accept that installments are not a pay as you go system and fees are still to be completely for a full term on a weekly or fortnightly option and are required to be complete by a set date by Smash Dance Company. I agree to commence debits on my chosen day that falls prior to the set commencement date provided by Smash Dance Company. If debits cannot commence prior to this date, I agree to deposit 205% of the fees upfront.

I agree that payments that default will incur fees of \$25.00 for each failed payment.

I agree to provide notification via email of any class cancelations, class changes, contact or medical information to Smash Dance Company via [admin@smashdancecompany.com](mailto:admin@smashdancecompany.com) and any adjustments if applicable will be made from the date of the email.

I accept unpaid fees will result in cancellation to private lessons, and withdrawal from solo competitions until balances are paid.

I accept that I cannot commence a new term until all previous term fees are paid.

I accept that footage of competition routines remains copyright of Smash Dance Company and is not to be uploaded to any social media platform without consent of the choreographer and studio owner/

I accept that Smash Dance Company has a zero tolerance on bullying, including but not limited to acts via social media, verbal or physical. Participating in such acts will result in dismissal from Smash Dance Company. Should you have concerns, please reach out via email.

I accept that public discrediting of Smash Dance Company or any of its staff and students in a public forum will result in dismissal.

I accept that I am responsible for any loss/damage to valuables brought onto the premises, and I waive Smash Dance Company form any and all responsibility.

I accept that I must park in the car bays provided, or utilise near-by parking, I am not to use the grassed area to park on. Smash Dance Company and the landlord of 25 buckingham dr reserves the right to issue fees for damages caused by parking here.
